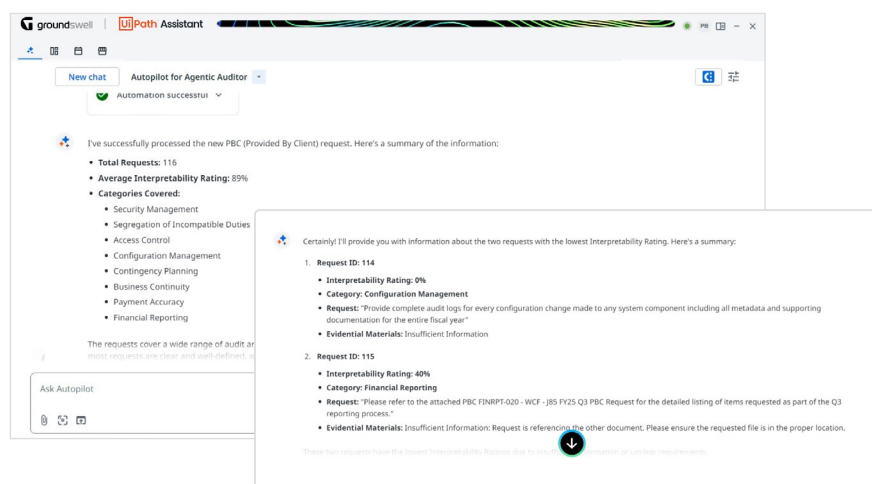


Figure 1. PBC Intake + Interpretability Scoring. Streamlines intake while scoring request clarity — accelerating task routing and resolution.

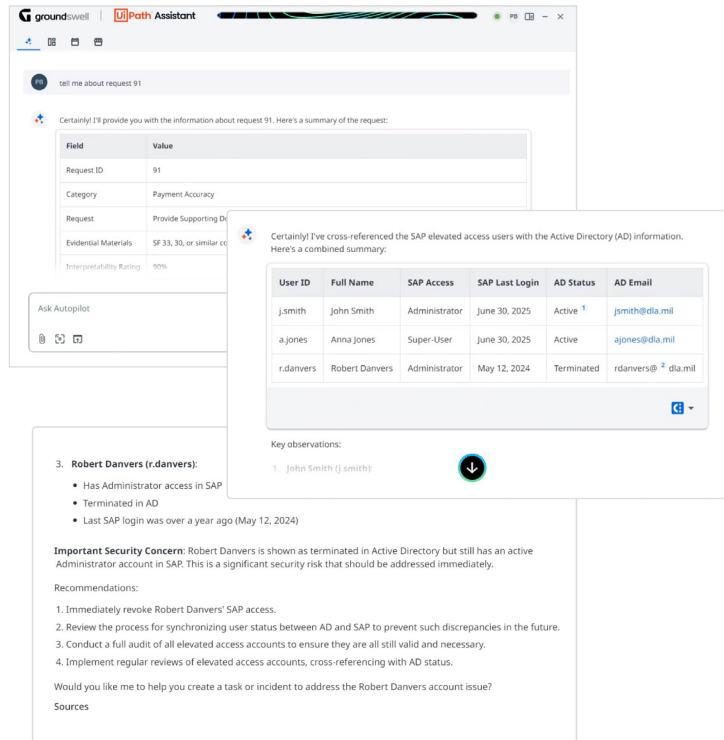


Figure 2. Audit support panels display user account status, personnel activity, and investigation references providing key operational details to inform audit response.

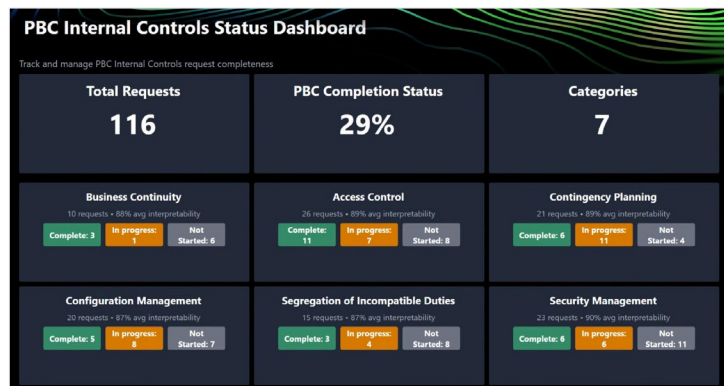


Figure 3. Audit Personas Dashboard. Delivers audit status, outstanding requests, and task ownership segmented by role.
